### VALENCIA v. BIMINI SUPERFAST, ET AL.

Circuit Court for Miami-Dade County, Florida  
**Employment & Labor/2015**

This employment case alleged personal injuries relating to an incident at a casino in Bimini, Bahamas. The jury returned a defense verdict.

### KLENET v. MIZNER PARK & GENERAL GROWTH PROPERTIES

Circuit Court for Broward County, Florida  
**Complex Tort & General Casualty/2013**

This case resulted from an incident at the Mizner Park Mall and involved clear liability. The pre-trial demand was \$500,000 and the defense offer was \$100,000. Verdict was \$88,500.

### ROGART v. TRIUMPH MOTORCYCLES AMERICA

Circuit Court for Palm Beach County, Florida  
**Product Liability/2011**

In a bench trial, we secured a defense verdict for our client, Triumph Motorcycles. The pre-suit demand was \$100,000 and no defense offer was made.

### VALDEZ v. PQ CONTROLS

Circuit Court for Miami-Dade County, Florida  
**Product Liability/2011**

This case alleged that a defective man-lift caused permanent and severe injuries to the plaintiff's legs and back. The pre-trial demand was \$6 million. A settlement was reached prior to jury selection for a confidential amount in the low six figures.

## EDEN v. KONGSBERG

Circuit Court for Miami-Dade County, Florida

**Product Liability/2010**

In this case, an allegedly defective loader manufactured by Teleflex/Kongsberg at the Port of Miami crushed the plaintiff's head. The pre-trial demand was \$18 million. In a settlement reached prior to jury selection, Kongsberg paid a confidential amount in the low six figures.

## SOTHEBY'S INTERNATIONAL REAL ESTATE v. WATERFRONT

Circuit Court for Palm Beach County, Florida

**Commercial Litigation/2009**

This arbitration proceeding involved a commercial dispute and claims of alleged fraud. We represented the plaintiff, Sotheby's, and secured a confidential six-figure sum from Waterfront.

## VESTA CONSTRUCTION v. LOTSPEICH

Circuit Court for Orange County, Florida

**Professional Liability/2008**

This professional liability matter involved a commercial development. The pre-trial demand was \$5 million. A settlement was reached at trial for a confidential amount in the six-figure range, less than the offer before the trial began.

## CLARK v. CYBEX INTERNATIONAL, INC., ET AL.

Circuit Court for Miami-Dade County, Florida

**Product Liability/2008**

An allegedly defective ergometer that was manufactured for medical rehabilitation allegedly caused permanent injuries to the plaintiff. The pre-trial demand was \$1.4 million and the jury demand was \$3.7 million. Obtained a defense verdict for our client Cybex (the jury found against the co-defendant and awarded the plaintiff \$1.7 million).

## NEVERS v. ELECTRIC MOBILITY

Circuit Court for Miami-Dade County, Florida

**Product Liability/2009**

An allegedly defective scooter lift was cited as the proximate cause of the amputation of the plaintiff's leg. The pre-trial demand was \$3 million and the jury demand was \$4.2 million. The jury returned a defense verdict.

## HYMEN v. BRODSKY

Circuit Court for Miami-Dade County, Florida  
**Professional Liability/2007**

This arbitration proceeding involved a malpractice lawsuit against an architect (our client) for claims related to development of a luxury residential property. The demand was \$1.85 million and the jury returned a defense verdict.

## WITTINGSLOW v. AMERICAN GOLF

Circuit Court for Collier County, Florida  
**Commercial Litigation/2006**

This commercial matter settled mid-trial for a confidential amount, less than six figures, that was very favorable to our client, American Golf. The pre-trial demand was \$1.35 million.

## CARVER v. FLORIDA PANTHERS AND NEW JERSEY DEVILS

Circuit Court for Broward County, Florida  
**Complex Tort & General Casualty/2005**

Plaintiff allegedly suffered a brain injury as a result of being struck by a puck while attending an NHL hockey game. The pre-trial demand was \$3 million and the defense offer was \$200,000. The jury demand was \$6.3 million. The jury returned a defense verdict.

## FOUTS v. JIM COLBERT GOLF

Circuit Court for Collier County, Florida  
**Commercial Litigation/2004**

This case involved a contractual dispute of \$150,000 and private club benefits for life; the demand totaled \$1 million. The jury returned a defense verdict.

## HERNANDEZ v. INVERNESS CORP.

Circuit Court for Miami-Dade County, Florida  
**Product Liability/2004**

Plaintiff alleged a defective product caused ear and facial injuries. The pre-trial demand was \$1.35 million and the defense offer was \$45,000. A settlement was reached at trial for a confidential amount less than the defense offer.

HEINFLING v.  
INTERNATIONAL LIFESTYLES

Circuit Court for Miami-Dade County, Florida  
**Commercial Litigation/2002**

Plaintiff alleged injury to commercial reputation. The pre-trial demand was \$1 million and no defense offer was made. The jury returned a defense verdict.
