Plaintiff's verdict for coverage and damages of approximately \$180,000.

Non-jury trial. Represented plaintiff in this subrogation matter. No cause.

Special master ruled for disbarment after hearing; reversed on appeal by DRB and Supreme Court and client was given short suspension.

Defense verdict for lawyer.

TOSCANO v. CONFIDENTIAL

Arbitration – Defense verdict for lawyer.

CONFIDENTIAL v. ESTATE OF SEMONIAN

Bench trial – No cause regarding legal malpractice. Court entered judgment for lawyer on unpaid fees of \$100,000, including pre-judgment interest..

LEE v. CONFIDENTIAL

Plaintiff verdict of \$100,000; judgement notwithstanding the verdict for defendants on post-trial motion; affirmed on appeal.

ELEZAB v. ST. JOSEPH'S HOSPITAL

Employment & Labor/2001

No cause in favor of our client and no appeal.

ROHM & HAAS ET AL. v. NATIONAL LEAD ET AL.

United States District Court, District of New Jersey
Environmental/2000

Non-jury trial that lasted about 30 trial days. Represented one of three plaintiffs in the contribution trial. All plaintiffs were no-caused.

HAWKINS v. HARRIS

Superior Court of New Jersey, Law Division,
Essex County
E&O/1996

Plaintiff sued investigators from underlying auto accident case claiming defamation, intentional infliction of emotional distress and other tortious conduct. Pretrial case went to New Jersey Supreme Court where we prevailed in narrowing the focus of the case in a 4–3 decision. Upon remand, jury verdict for our clients.

MUSKA v. MEMORIAL SLOAN KETTERING

Superior Court of New Jersey, Middlesex County
Medical Malpractice/1995

Medical malpractice allegation concerning a negligent surgical injury during an operation on the plaintiff's lung. At jury trial, the trial judge granted a directed verdict at close of plaintiff's case based on cross-examination of plaintiff's expert. Appellate Division affirmed.

TWIN CITY FIRE v. HCM CLAIMS MANAGEMENT

Non-jury. Judgment of \$225,000, including our attorney fees entered for our client on its counterclaim. Appellate Division affirmed.

DIAMOND SHAMROCK v. AETNA

Environmental/1988

Non-jury. Judgment largely for defendants. Affirmed on appeal in a reported decision, 258 N.J. Super. 167 (App. Div. 1992). Our client paid \$0.

LELAND v. SINGER

United States District Court, District of New Jersey
Age Discrimination/1988

Judgment for plaintiff; new trial motion granted on a portion of the claims; case then settled on appeal.

CATLIANNI v. MCGUIRE

Superior Court of New Jersey, Law Division,
Morris County
Auto Accident/1984

Represented the defendant on a counterclaim for personal injuries and was no-caused.
